Kansas Rally Weekend Rally Reports

The 2007 Kansas Rally weekend was held November 10 and 11, 2007. The weekend featured two rallies to kick off the 2008 road rally schedule.

Saturday's event, sanctioned by the Kansas City Region of the SCCA, was the all-paved event Jarbalo Jog III. The event started in Lenexa, Kansas and wound its way through the counties of Leavenworth, Jefferson and Douglas, ending near Lawrence. True to its name, the route jogged through the hamlet of Jarbalo in Leavenworth County.

Winning the event were Kansas Region members Randy Gregg and Lonnie Worthington with 59 points (at one point per second) over 5 legs. In second place were Kansas City Region members (and 2005 Jarbalo Jog winners) Neava Ford and Charlie Clark with 200 points. With this second place position Neava and Charlie are officially no longer classified in the Novice class. The father and daughter team of Bill and Chris Cutrer scored the events only 0 with a perfect score on leg 4.
