Motorsports Photography: Don't Forget the People

Myth: Motorsports photography is all about the cars.

Whenever people think of motorsports photography, they think only about the racing machines. Anyone who has been to a race track just to spectate, let alone compete, understands that just getting a car on the track takes an enormous effort from a large number of people.

Techniques: Image drivers and crew in their natural habitat.

When you do see photos of people at a race, they're often shots of fans posing for the camera. While that type of fan enthusiasm shot can be useful, the more powerful images are of the crew hard at work,



thrashing to get their machines in top order, the intensity of the drivers as they prepare to compete, and the officials as they prepare to fulfill their roles to make the event run smoothly.

If you can, always purchase a paddock pass with your race ticket. The garage areas are the best places to capture drivers and crew in candid moments. Certainly, it's the best place to capture the crew working on their machines, but it's also a great place to capture the crew and drivers in those moments between sessions. It's also a great place to see drivers and fans interacting.

The drivers themselves as they prepare for a

race can provide a wide variety of dramatic images that convey the nervous tension before they head out onto the track. Their countenance is almost always one of serious contemplation and determination. It can really demonstrate how serious racers are about their craft and the task before them.

In contrast to the very serious and somber pre-race mood, post-race or qualifying celebrations portray the joy and jubilation that comes from being victorious after lap after lap of stress, tension, and struggle. Again, it helps to have a paddock pass. You might think a paddock pass is pricey, but when you see the emotion on the face of a young racing driver that has just won the biggest race of his career, it will all be worth it.

So remember, next time you're at a race, whether it's the sportscar race at the Kansas Speedway, the Rally in the 100 Acre Wood, or even one of our local club races, autocrosses, rallycrosses, or road rallies, don't forget the people. After all, that's where the real passion for our sport resides, in the people.

REMEMBER WHEN

The Sports Car Club of America, Inc. was founded on February 26, 1944 by seven men in Connecticut who had a dream....a dream that became a reality and awakened the interest of thousands of people. The small local club later became the New England Region. In July 1945, the first SCCA time trials event was held at Thompson, Conn. On June 20, 1948 the first race with SCCA drivers was held at Langhorne, Pennsylvania on a one mile dirt track. Then October 1948, SCCA conducted it first race, in Watkins Glen, NY. September 1952, racing on public roads was halted and one month later, a deal to hold races on Strategic Aid Command runways was signed. By 1948 the membership had risen to over 300. Today we have 60,000 members and there are 115 regions. A monthly magazine was first published in 1944 and was known as "Sportswagen" which was later renamed Sports Car Magazine.

To answer the question, "What is the Sports Car Club of America and what does it do?" we can quote directly from the By-Laws of the original New England Region club. "PURPOSE. The general purposes of the Club shall be to encourage the preservation, ownership and operation of Sports Cars, to act as a source of technical information, to establish rules and regulations covering all activities of the Sports Car Club, to provide and regulate events and exhibitions for Sports Cars and their owners, and to encourage careful and skillful driving on public highways."

E. Tom Newcomer and Barney McCray both remembered the Kansas City Region, SCCA getting started in the spring of 1950. Membership cards were issued to E Tom Newcomer and John Ross in May, 1951 and the first RE was Marsh Kennedy. We were incorporated in Kansas City, MO on August 20, 1952. The president (RE) was J. E. (Pete) Lynn, secretary was E. Tom Newcomer and treasurer was K.E. Schondelmaier. In 1952 there were 21 KCR paying members and now in 2013 we have 514 members. In 1952 local dues were \$5.00 and national dues were \$10.00 and you had to pay additional \$2.50 for the monthly magazine if you wanted it. Our local dues today are \$20.00 and national dues are \$65.00 (this includes the magazine). We now have family memberships (husband, wife and children under 21 years of age) and First Gear (for members age 24 and under). The Kansas City Region's first regional publication was published on March 24th, 1955 and was called "The Wheel". It later became Checkpoint in 1958.

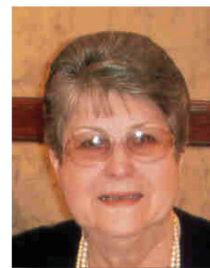
