



NOTICE *** NOTICE *** NOTICE

Per our bylaws a 30 day notice is given and the proposed changes will be discussed at the General Meeting June 7, 2016. Ballots will be due and counted at the General Meeting, July 5, 2016.

At the KCR SCCA Board meeting February 23, 2016, a motion was made and passed by the board to make the following amendments: **Proposal 1**

Article VI, Section 1 – Add "Tenure shall be limited to 2 consecutive terms" to the end of the section.

Section 1. Board of Directors. The Board shall establish the policies of the Region and shall oversee and direct the implementation and execution of such policies and the administration of the affairs of the Region by the executive committee, and such other committees as it determines to appoint and authorize. The 6 non-officer Directors shall be elected for 2 year terms which shall be staggered, such that 3 Directors are elected at each annual election. <u>Tenure shall be limited to 2 consecutive terms.</u>

Proposal 2 - The remaining amendments are to simplify the language on giving notice:

Article II, Section 5(a) – Replace "letter, e-mail, or other verifiable method of communication addressed to" with "notifying". Replace "communication" with "notice"

Section 5. Termination, Suspension, and Renewal.

(a) Any member may resign by letter, e-mail, or other verifiable method of communication addressed to notifying the Secretary of the Region. The resignation shall be effective upon receipt of the communication notice. Such resignation shall not relieve the member of the obligation to pay dues, assessments, or other charges accrued and unpaid.

Article II, Section 5(d) – Remove "in writing"

(d) The Board of the Region may suspend, terminate, or fine a member from the Region at any time for infraction of any SCCA and/or Regional rule or any other cause if the Board deems the action in the best interests of the Region, provided that the Board will afford the member a reasonable opportunity to be heard by it or by a committee appointed by it, in person or through a representative, prior to taking any action, unless it deems it imperative to suspend the member before a hearing can be held, in which case it shall immediately notify the member, in writing of the suspension. In the case of an immediate suspension, after hearing, the Board may continue for a definite term or rescind the suspension, or terminate the member, and its decision shall be final. Suspension, termination, and/or fine requires affirmative vote by at least two-thirds of all members of the Board, elected and serving.

Article II, Section 5(f) – Replace "Upon written request by letter, e-mail, or other verifiable method of communication, signed by a terminated member and filed with the Board," with "A terminated member may request to be reinstated by filing a signed notice with the Board;"

(f) Upon written request by letter, e-mail, or other verifiable method of communication, signed by a terminated member and filed with the Board, A terminated member may request to be reinstated by filing a signed notice with the Board; said Board may by unanimous vote to reinstate such former member to membership upon such terms as the Board may deem appropriate.

Article III, Section 1 – Remove "The notice may come in the form of a letter or postcard, an article in our Regional publication whether printed or electronic, an e-mail, or other verifiable method of communication."

Section 1. Annual Meeting. The annual meeting of the Region shall be held each calendar year on the first Tuesday in December, or such other time within 30 days of such date as determined by the Board for the election of Officers and Directors for the Board and the presentation of reports from the officers, committees and boards, and such other business as may lawfully come before the meeting. The Secretary shall send each Regional member a notice of such meeting not more than 45 and not less than 14 days prior to such meeting setting forth the date, hour, and place of such meeting and all business to be transacted there. The notice may come in the form of a letter or postcard, an article in our Regional publication whether printed or electronic, an e-mail, or other verifiable method of communication.

Article III, Section 6 – Replace "written request, e-mail, or other verifiable method of communication" with "request" Section 6. Special Board Meetings. A special meeting of the Board may be called by the Regional Executive or upon written request, e-mail, or other verifiable method of communication request of any 5 Board members. At least a 2 day notice by mail or a 1 day notice by phone or e-mail of such special Board meeting shall be given to all Board members. The notice shall state the objective of such meeting.

Article VII, Section 1 – Replace "indicate in writing by letter, e-mail, or other verifiable method of communication" with "provide notice" Section 1. Requirements for Candidacy. Any member of the Region shall be eligible for nomination to the Board if he or she is a member in good standing and will have been a member at least 1 year at the time he or she would take office. Nominees for the office of Regional Executive shall have served at least 1 year on the Board. Nominees for the office of Treasurer shall be eligible to be bonded.

Each candidate must indicate in writing by letter, e-mail, or other verifiable method of communication provide notice to the Nominating Committee or to the Secretary that he or she is a willing candidate for office and is agreeable and willing to serve in said office if elected.

Article VII, Section 3 – Replace "mailed" with "distributed"

Section 3. Balloting for General Election. All voting for election of members to the Board who have met nomination requirements shall be by written ballot or through electronic means as may be established by the Board then serving. Appropriate ballots shall be

prepared by the Secretary and mailed distributed to the members following the close of nominations. If electronic balloting is offered, the electronic ballot shall be functional and accessible within 2 days following the close of nominations. A biographical sketch as provided by the candidate shall also be mailed to all members prior to the electronic balloting is offered, the biographical sketches shall be posted along with the ballot.

Article XI –Reference the final sentence, "The general membership must be given notice of proposed changes and the nature thereof in writing at least 30 days prior to such meeting at which changes are presented for consideration" remove "in writing" and replace "mailing" with "distributing" AND move the sentence to just after "The proposal shall be approved by a majority of the Board before being submitted to the members" and just before "by mailing a notice..."

Amendment Procedures

The Board or 3 per cent or more of the members may propose an amendment to the certificate of incorporation or bylaws by submitting such proposal in writing to the secretary. A proposal submitted by the members shall be reviewed by a committee of 5 regular members, consisting of 4 members appointed by the Board, 2 of whom are members proposing the amendment, and a 5th member appointed by these 4 members, who shall act as a chairperson. The committee shall consider the propriety of the proposal, taking into account the intent of the petitioners and the suitability of the inclusion of the proposal in primary instruments such as the certificate of incorporation and bylaws, and shall draft the proposed amendment into suitable language. The proposal shall be approved by a majority of the Board before being submitted to the members. The general membership must be given notice of proposed changes and the nature thereof in writing at least 30 days prior to such meeting at which changes are presented for consideration by mailing distributing a notice of the proposal and a form of a ballot to all members. Each member shall be entitled to 1 vote on each proposal submitted to the membership. At least 30 days shall be allowed for voting. Ballots shall be mailed to the Region prior to the designated regular or special meeting or delivered to the Secretary at the designated regular or special meeting of the Region. If electronic balloting is offered, voting shall be closed 24 hours prior to the start of the designated regular or special meeting in order to give the Secretary time to download the results to be counted. Provisions shall be in place to verify that mailed ballots and electronic ballots do not originate from the same member. If at least two-thirds of the members voting are in favor of the amendment, it shall be adopted. The secretary shall cause the result of the balloting to be published for the information of the entire membership.

Convention by James Cahill

I had an awesome roommate. If that one line interests you, read on.

I attended the 2016 National Convention as a representative of both KC and KS region boards. This was the first National Convention I have been to, so I wasn't sure what to expect. I hoped to see some old friends from other regions, meet some new people, build networking connections, and based on the synopsis of many of the sessions, bring back some good information and strategies to strengthen both regions.

I ran into Al Hermans while flying out there. We talked some shop on the way and started to develop a plan of attack for KCR to get the most out of what was offered. We arrived at the South Point on Thursday night and got settled in. Brad Smith arrived later that night. On Friday morning, the three of us met up with Frank Wietharn and nailed down who would go to what session so we could spread ourselves around, learn what we could, and put it all back on the table.

While I won't go into all the details of every session I attended, here are some highlights in no particular order-

- treating EVERY event as a place to have fun is very important, it's not just about trophies
- social media can and will build your region, not just Facebook, but any number of other platforms
- get more people involved in more events, cross promote at every event
- get the community involved through outreach and giving back, it's not just about SCCA
- try new things, sometimes the current way isn't always the best
- use events to draw people in who otherwise would have no interest by changing things up a bit
- the new SCCA.com is still under development, but should be pretty nice when it's done
- cool new gear for SOLO, cameras, dataloggers, etc

Following all the sessions on Friday and Saturday, the annual banquet was held. I don't even remember what the choices were, but all of them were good. Sitting at a table with a few open seats allows you to pretend like the guy next to you didn't get his desert. I'm not saying I did that, but it may have happened at our table. Following dinner, the Hall of Fame inductees were introduced and inducted. Many of the exploits and accomplishments of these people are incredible. The videos created to accompany the awards were amazing.

On Sunday morning, I attended the Tire Rack Street Survival Summit. TRSS organizers from all over the country, from multiple sanctioning bodies were present. From all accounts, TRSS is an incredible program. Guest speakers were able to give us the information we need to not only keep our current programs successful, but build and develop them. The raw data put out about teen driving accidents and how it relates to TRSS is pretty interesting. The program works, and I'm happy to be a part of it.

On the social side of the convention, I ate more food than I have in quite some time, played some poker, watched a live show, and became strangely interested in electronic bingo. I did see some old friends from regions past, made some new friends, and overall had a great time. I would have liked to see some more of Vegas, so next year I'll probably go out a few days early to take it in.

I left the South Point on Sunday afternoon. I got to have a candid discussion with Brian Connors (SEB chair) about how Cavaliers are classed while on the shuttle to the airport, and after I got to my gate, I realized I was in line next to Lisa Noble.
